NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2022

NOTE 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is prepared to satisfy the financial reporting requirements of the Constitution, the Associations Incorporation Act (WA) 2015 and the Australian Charities and Not-for-profits Commission Act 2012.

The financial report has been prepared in accordance with the requirements of the Constitution, Associations Incorporation Act 2015, the Australian Charities and Not-for-profits Commission Act 2012.

NOTE 2. AUDIT

Australian Charities and Not-for-profits Commission (ACNC) consider a charity "small" if it has revenue of less than \$250,000.

For this financial year LTFRG revenue was \$78,358.78. On this basis the committee elected not to have the books audited for this financial year.

NOTE 3. TAXATION

The Australian Taxation Office has endorsed the Ludlow Tuart Forest Restoration Group Inc. (LTFRG) as a Charity, and it is eligible for the following concessions:

- (i) GST Concession
- (ii) FBT rebate
- (iii) Income taxation exemption

Ludlow Tuart Forest Restoration Group Inc. – was endorsed as a Deductible Gift Recipient (DGR) effective 29 April 2020.

No change in its tax status because of activities undertaken during the year is likely.

NOTE 4. ECONOMIC DEPENDENCY

Ludlow Tuart Forest Restoration Group Inc. receives funding from various funding providers and Local Governments.

The ability of Ludlow Tuart Forest Restoration Group Inc. to continue as a going concern is dependent upon continued receipt of funds from funding providers.
